Paul Rich is running for Sheriff to address the Board – Paul Rich introduced himself to the Board and discussed his bid for the Sanilac Sheriff position.

Gary Heberling gave a Commissioner's report –

- Bill 690 was signed by the Governor. The bill provides stimulus funds for First Responders, and the Sherriff's Department. There will be a \$1,000 bonus checks for each of them and checks will be cut this Friday.
- Also, part of the 690 Bill, there are funds allocated for cities, townships, and villages affected by COVID-19. Applications must be filled out by city, township or village officials. On Thursday, there will be a webinar put on by the State Treasury. Mr. Heberling will send the information to Scott Franzel.
- Commissioners reviewed the current process for testing visitors and employees entering the courthouse and how long this is expected to go on. Bryant Wilke, Health Director expects the necessity for testing will be needed for the next 18 months. Due to the Governor's mandate, the Health Department has

- been contracted with to provide the service at \$1,500 a week for now and other options are being explored.
- Commissioners are exploring High Speed Internet. The need has really been noticed due to COVID-19 and people working from home. So, there is a push to get this done in the next few months for the County. COVID-19 funds may be used for this.
- A meeting was held with Roger Ballard to discuss his upcoming retirement and how this position will be replaced.
