SEWER REPORT

Kenny reported that:

- Starting on September 1st, the City of Sandusky is moving to monthly water/sewer invoicing versus quarterly. It is up to the Board to continue with quarterly or monthly township billings. However, the City may require monthly payments.
- Michigan Pipeline is not an engineering firm and therefore, does not recommend sewer changes. The company is asking the amount of funds available in the Sewer Fund, so they can contact an engineering firm to have a study done. Coats explained that there is not a separate sewer fund, but there is a sewer account within the Township Fund. The two engineering companies that were contacted do not want the job. Kenny will contact other engineering companies.
- Next sewer meter reading is September 1st.
