Discussion regarding John Bezotte's excellent service at maintaining minutes by Dick Henderson.

Discussed 5 year plan for VFW parking lot. Initially presented 5 year plan, Rich will monitor them as they proceed in the future. Dick discussed VFW will have no parking on road. VFW had contacted County, they said to contact the Township regarding parking on road. Rich will work with them on their plan to blacktop parking lot.

Marijuana – should we pass anything at township level. Discussion – Gary Howell will let us know how it was taken care of at next meeting, regulatory ordinance.

Windmills – Suggest start at top and go down thru list, what do we like and possible additions to chart put together on "Wind Energy Issues Worksheet." Ed suggested we use Elmwood as a guideline and make possible changes to theirs. Discussed bonding issues, 30-50 years life. Rich said on news County is trying to get out of bonding. Cost is 50,000 to 100,000 to tear down. Ed presented Elmwood, Gary said Township created overlay district. Township would declare where districts would be. No high ridges in Watertown Township.

D-1 Decommissioning if 24 months vacant – Use Ottawa's decommissioning language.

Electromagnetic – Not allowed, Ottawa Twp

Erosion – Show compliance with State guidelines, soil erosion & sedimentation

Flicker – 30 hours per year require study, impact study lighting from FAA concerns.

Hub Height – Clearance from blade height, max height, clearance 75, hub height 275

Human Health – skip over

Infrastructure – Travel Plan & repairing at their own expense by owner, operator

Large Wind Generation – difference of large & small wind generation.

Noise – discourage limiting, Use Bridgehampton

Property Values – Form – File a claim against windmill

Safety – Follow all Federal & State laws, gates, fencing, etc.

Setbacks – Hub height, or ¼ mile, or sign an easement.

Encourage Pooling – makes people happier & Define pooling

Setbacks Public Roads, Lines, Utilities – generally less 1 ½ hub height

Setbacks Property Line Participating – Use Structure Setbacks

Setback Structures Participating – 1 ½ hub height or 1000 feet

Small Wind Generation – Residential windmills, exempt from large windmill requirements, use Elmwood rules.

Utilities to Connect Point – Underground

Visual Impact – See Sheet, no change

Wildlife / Hunting – Submit on Avian Analysis

Regulation – Permit required, Site plan, Construction Bond, Plan Review.

Need to address Fire Protection, Watch and Burn, Clean-up / EPA, DEQ would handle.

Send to Gary Howell for review. All agreed, ready to submit.

Any comments: Solar Panel at Caulkins is quite noticeable. Next meeting is September 20, 2012, 3<sup>rd</sup> Thursday of September.
