PUBLIC COMMENTS:

- 1. Rick Pangborn a 50yr resident of Watertown Township has been involved with this solar fiasco since the start and has decided to sell his house. He has had 2 buyers with offers that exceeded the asking price and because of solar the buyers backed out. He can't sell because of the possibility of solar and it's a misconception that solar is adding value.
- 2. Mike Smith a Watertown resident for 38 years thanks the Planning Commission and talked about Jason Hayes from the Mackinaw Center for Public Policy giving a presentation to We The County. The conclusion is that wind and solar as a primary source of electricity is not going to maintain our electric needs. He talked about Public Act 233 and that once solar is on high quality farm land the odds are unlikely that the land will ever be farmed again. He also talked about the 4,000-acre solar complex in Texas that got pummeled by hail and the toxic heavy metals that are leaking into the ground. He also gave some figures from Jason Hayes that if we reach "Net Carbon Zero" for carbon output by year 2100 the thermometer will only move by .0015 degrees Celsius.

NEW BUSINESS:

1. Discussion of the Watertown Solar Public Hearing being postponed. Notification of the public hearing was not mailed out to the correct residents therefore it could not take place. Discussion of when to have it next and with the Master Plan already on the agenda for May the following motion was made.

2. Discussion of the Solar Ordinance redline review amendment from Foster & Swift started last year. The PC discussed and Becky is going to email Foster & Swift for them to put a final draft together.

- 1. The PC discussed Twp. ordinances and would like to get together a list of all the ordinances and move forward with updating the ordinance book.
- 2. The Master Plan public hearing is scheduled for May and the Spicer Group is handling the postings. They are supposed to have bound copies for the Planning Commission.
