NEW BUSINESS

Letter from Mike Homier of Foster and Swift to discuss and address the Treasurer issues as stated in #1 and #2 in his email to the Township Supervisor Henderson.

1.) Henderson led a discussion on the Treasurer issues and a new procedure for mail collection.

*** Motion by Henderson, supported by Radloff to authorize the Township Attorney to initiate legal action on behalf of the Township against the Township Treasurer, seeking (1) an order compelling the Treasurer to comply with all laws and ordinances applicable to her office and fulfill all duties of her office, and (2) an injunction prohibiting the Treasurer from interfering with duties assigned by statute to the other township offices, with the legal characterization and form of such claims to be determined in the Township Attorney's professional judgment.

Hacker, Henderson, Radloff, & Ross in favor by stating aye.

Coats left the meeting right after Radloff supported prior to the completion of this motion. Motion carried.

New mail collection Procedure

2.) Hacker led a discussion on All Township mail to be collected by the Township Clerk

*** Motion by Hacker, supported by Radloff to approve the new mail collection procedure as presented. Hacker, Henderson, Radloff, & Ross in favor by roll call vote.
